**RECOMMENDATION FOR THE AWARD OF CONTRACT FOR THE SUPPLY OF
UNIFORM SOFT SHELL JACKETS AND MICROFLEECEES**

1. PURPOSE OF THE REPORT

To seek approval for the award of a contract under the West Yorkshire Police (WYP) national framework agreement for the supply of Uniform Soft Shell Jackets and Microfleecees for the period of 1 February 2017 to 31 January 2021 for the estimated total contract value of £50,000.

2. INFORMATION AND ANALYSIS

WYP ran a tender on behalf of all UK Police forces to deliver the national standard specification uniform items noted above.

WYP evaluated bids from potential suppliers and reported results of the tendering process to the national uniform group, who then endorsed the award of contracts to Tailored Image Ltd and Hunter Apparel Solutions Ltd. Accessing the national framework delivers economies of scale and reduced lead times for the delivery of these uniforms items.

Estimated annual spend via the framework is expected to be circa £50,000 approximately £22,000 less than with the previous supplier.

3. RECOMMENDATIONS

Award contracts to Tailored Image Ltd and Hunter Apparel Solutions Ltd for the period of 1 February 2017 to 31 January 2021 for the estimated total contract value of £50,000.
