1 PURPOSE OF THE REPORT

- 1.1 Recommend approval to award a contract for the provision of a voluntary offender management solution provided by Buddi UK Ltd for the period of 1st November 2017 to 31st October 2018. Contract value £16,200.

2 INFORMATION AND ANALYSIS

- 2.1 The Integrated Offender Management (IOM) scheme have been successful in gaining funding for some GPS trackers. They are tags worn on a voluntary basis by offenders as part of efforts by the Police to reduce their re-offending.
- 2.2 Derbyshire Constabulary have worked with Buddi UK in recent years and as a consequence Derbyshire Officers and Staff have a sound working knowledge of the Buddi systems, tag operation and data management procedures.
- 2.3 The Crown Commercial Services (CCS) G-Cloud 9 Framework was identified as a compliant route to market, Buddi UK are a provider on this Framework
