## Regional Collaboration - PCC's Decision Log

### Decision Required

To seek approval to purchase and implement a new regional web based system for the overseas registration of foreign nationals living within the UK.

### Executive Summary & Governance.

The regional CC's have supported the option to implement a regional web based solution for the registration of foreign nationals through the purchase of a software system from Nine Software Company, with a contract duration of 3 years. The total 3 year cost of the software and installation is £113,449, There is a further annual cost of £9,480 for support and maintenance and hosting.

It is recommended that each force contributes a proportion of the cost based on the average number of police registrations completed per year. The proposed recharges per force are shown in the following table.
