**AWARDING THE ADULT SEXUAL ASSAULT REFERRAL CENTRE AND  
INDEPENDENT SEXUAL VIOLENCE ADVISOR SERVICE CONTRACT FOR  
DERBYSHIRE**

**1. PURPOSE OF THE REPORT**

- 1.1 To inform of the joint Commissioning arrangement to deliver an Adult Sexual Assault Referral Centre (ASARC) and ISVA service contract for Derbyshire
- 1.2 To approve the NHSE contract award to SV2 to deliver the ASARC and ISVA service for Derbyshire

**2. INFORMATION AND ANALYSIS**

- 2.1 The current ASARC and ISVA service, provided by SV2 is contracted by NHSE and due to expire March 31<sup>st</sup> 2018.
- 2.2 The current service is jointly funded by NHSE, Derbyshire County Council and Derbyshire Constabulary
- 2.3 The Forensic Medical Examination (FME) service is contracted by the Constabulary as part of the integral response of the ASARC
- 2.4 The aim of the joint arrangement is to integrate those services, clarify funding and partners, and jointly procure a service against a new specification supported by a Legal Partnership Agreement between those funding partners
- 2.5 Following the procurement process a preferred provider was identified and it is the intention of the NHSE to award the 3 +1+1 year contract to SV2 as the preferred provider.
- 2.6 The value of this contract funded by all partners will be £415,000.

2.7 The FME contract would remain with the Constabulary to work alongside the ASARC service
