### POLICE AND CRIME COMMISSIONER MULTI -YEAR GRANT ALLOCATIONS 2018

#### Executive Summary:

1. A number of partners contribute to the current programmes for community safety, crime reduction and antisocial behaviour across the county and city. Community Safety Grant Agreements specify the outcomes agreed with each provider and partners are required to provide satisfactory information on outcomes in support of the Police and Crime Plan objectives, realised from previous spend. This funding supports a range of multi-year interventions (see the full report containing Table 1 at 2.6).
2. Working extensively with partners across the city and county and using evidence based approach to service delivery, the above organisations will deliver positive and effective interventions to a range of vulnerable cohorts.
3. The extension of the agreements together with the established links with key partners across Derbyshire provides added value as well as consistency and continuity of service provision.

## 1. **OVERVIEW**

- 1.1 A number of partners contribute to the current programmes for community safety, crime reduction and antisocial behaviour across the county and city. Community Safety Grant Agreements specify the outcomes agreed with each provider and partners are required to provide satisfactory information on outcomes in support of the Police and Crime Plan objectives, realised from previous spend. This funding supports a range of multi-year interventions (see Table 1 at 2.6).
  - 1.2 Working extensively with partners across the city and county and using evidence based approach to service delivery, the above organisations will deliver positive and effective interventions to a range of vulnerable cohorts.
2. The extension of the agreements together with the established links with key partners across Derbyshire provides added value as well as consistency and continuity of service provision. In the case of each agreement an assessment has taken place as to:
- whether there is currently sufficient information around evidence based practice, demand in terms of target populations, and efficacy of intervention in producing outcomes.
  - whether the market is mature or wide enough to respond to a managed procurement exercise
  - whether the value for money assessment is possible with the limitations of detail available – this supporting a decision re adequate budget.
  - the wider social impact of the projects
- 2.1 Our assessment has concluded that there are currently gaps in comparative information around evidence, demand, costs and market maturity preventing a robust procurement exercise in all three instances to take place at this time. In addition we have determined that a commissioning review of “area” and “reach” needs to take place for each project concurrent with delivery to assess the impact of longer term commissioning on the PCC’s priorities, against other

comparable interventions.

2.2 It is considered that this funding offers good value for money when considering the number of potential beneficiaries and the amount of funding required to secure an enhanced service based on an established model.

2.3 Grant criteria and minimum data sets will be provided and recipients are required to provide regular financial and activity reports.
