**RECOMMENDATION TO AWARD THE CONTRACT FOR THE PROVISION OF  
SUPPORT FOR YOUNG PEOPLE AS VICTIMS OF CRIME**

**1 PURPOSE OF THE REPORT**

- 1.1 Recommend approval to award contract for the Provision of Support for Young People as Victims of Crime to Remedi (Restorative Services), for the period of 1 April 2018 to 31 March 2021, with the option to extend for a further 2 x 12 months, for the total contract value of £180,000.

**2 INFORMATION AND ANALYSIS**

- 2.1 On the 1 October 2014, the Police and Crime Commissioner (PCC) for Derbyshire took over responsibility from the Ministry of Justice for commissioning victims services. Derbyshire was one of seven PCC areas nationally which were early adopters of the new commissioning system, ahead of the deadline of the 1 April 2015.
- 2.2 The current contract with Remedi (Restorative Services) is due to expire on 31 March 2018.
- 2.3 The evaluation team consisted of Kevin Gillott (Deputy Police and Crime Commissioner), Mary Bosworth (Head of Commissioning, OPCC), Dave Bond (Children's Services, Derbyshire County Council), Julie Harper (Head of Commissioning and Partnerships, Derbyshire County Council), Rob Atkinson (Procurement Officer) and Kirsty Holding (Procurement Assistant) for Derbyshire Constabulary.
- 2.4 This further competition was an EU Open Procedure. 15 suppliers expressed an interest in this tender. 1 supplier submitted a bid: Remedi (Restorative Services).
- 2.5 Based on the detailed evaluation, as Remedi (Restorative Services) were the only bidder they received the highest possible marks for their response. They demonstrated that they could meet the requirements which were outlined within the specification and provided a comprehensive response to the method statements.

### 3 RECOMMENDATIONS

3.1 Confirm the recommendation to award the contract to Remedi (Restorative Services) for the period of 1 April 2018 to 31 March 2021, with the option to extend for a further 2 x 12 months, for the total contract value of £180,000.
