**RECOMMENDATION TO AWARD THE CONTRACT FOR THE PROVISION OF  
RESTORATIVE JUSTICE SERVICES FOR DERBYSHIRE**

**1 PURPOSE OF THE REPORT**

- 1.1 Recommend approval to award contract for the Provision of Restorative Justice Services for Derbyshire to Remedi (Restorative Services) for the period of 1 April 2018 to 31 March 2021, with the option to extend for a further 2 x 12 months, for the total contract value of £420,000.

**2 INFORMATION AND ANALYSIS**

- 2.1 From 1 October 2014, responsibility for commissioning support services for victims and Restorative Justice (RJ) services transferred from the Ministry of Justice (MoJ) to the Derbyshire Police and Crime Commissioner (PCC). The Commissioner now receives a grant from the MoJ to commission RJ services for victims.
- 2.2 The PCC therefore commissioned an RJ service from 2013 to 2018, and the contract for this service will expire of 31 March 2018, therefore the Commissioner now wishes to retender that service for delivery from 1 April 2018.
- 2.3 This competition was an EU Open Procedure. 11 suppliers expressed an interest in this tender. 2 suppliers submitted a bid.
- 2.4 The submissions were evaluated against the Most Economical Advantageous Tender Criteria (MEAT): Weighting 40% Price 60% Quality.
- 2.5 Based on the detailed evaluation, Remedi (Restorative Services) received the highest possible marks for their responses. Remedi (Restorative Services) demonstrated that they could meet the requirements which were outlined within the specification. They provided a comprehensive response to the method statements.

2.6 Based on the evaluation of the pricing schedules, both Remedi (Restorative Services) and Respect and Restore Training Limited received the full 40 points, as they both quoted £140,000.00 within their submission.

### 3 RECOMMENDATIONS

3.1 Confirm the recommendation to award the contract to Remedi (Restorative Services) for the period of 1 April 2018 to 31 March 2021, with the option to extend for a further 2 x 12 months, for the total contract value of £420,000.
