## OVERVIEW

Both Derbyshire Constabulary and Northamptonshire Police's fleet department require new Personnel Protected Carriers (PPC), therefore a regional procurement was carried out.

## INFORMATION ANALYSIS

This further competition was conducted under the Crown Commercial Service Framework RM1070, Lot 2. 17 suppliers were invited to respond to this tender. 7 suppliers expressed an interest and 2 suppliers submitted a bid.

Based on the detailed evaluation, Volkswagen Group UK Limited received the highest possible marks for their quality response. They demonstrated that they could meet the requirements which were outlined within the specification and provided a comprehensive response to the method statements.

Volkswagen Group UK Limited received the highest possible points for their price submission, as they were the cheapest submission. The submission from Volkswagen Group UK Limited was within the original budget was set for this procurement.
