**RECOMMENDATION TO AWARD THE CONTRACT FOR THE PROVISION OF
ASBESTOS SURVEYS ACROSS THE PROPERTY PORTFOLIO.**

1 PURPOSE OF THE REPORT

To recommend that we award the contract to Environtec Limited, currently we do not have any formal contract in place for this area of Statutory Compliance work. We have a duty of care to employees and contractors working on our sites, to provide a safe environment, the lack of surveys and the uncertainty around recommended works being completed, is not acceptable. This contract will ensure going forward the Force has gained control of this important aspect of property management.

2 INFORMATION AND ANALYSIS

Previously the contract was with RLB, however, the surveys lapsed and the consultant was remiss in ensuring our properties were surveyed and reports submitted for any follow on works. As a result of this, any surveys we have that were submitted prior to RLB being awarded the contract, are outdated, with any possible intended follow on works required, still not completed.

The tender was run using an Efficiency East Midlands Framework, EE0024-2 OJEU Notice 2016/S 020-031462, using the Further Competition option.

The Framework evaluation criteria were based on 60 % Quality and 40% Cost. The tender to be awarded to the Most Economical Advantageous Tender, (MEAT) evaluating against the technical and general requirements, and cost were applied.

Quality is paramount in this service, and Environtec Limited have provided excellent detailed answers, and have backed up their responses with case studies, and demonstrated their ability to support the Force through this program of work. It is also notable that Environtec Limited have offered a quality training package for our employees, which is recognised and trackable. For these reasons Environtec Limited scored maximum points for quality.
