The Commissioner has committed additional funding for a single consistent specification for a Derbyshire wide IDVA service, to protect a consistent standard of service for victims, against a single system linked with the criminal justice system. The cost for this additional resource is £55,000 per annum.

OVERVIEW

A single consistent specification has been developed for a Derbyshire wide IDVA service, to protect a consistent standard of service for victims against a single system linked with the criminal justice system.

INFORMATION ANALYSIS

The procurement is split into two: the County leading the procurement for the County and the PCC leading this for the City.

Procurement timetables, questions and scoring is aligned.

There is an option to provide duty cover for 365 days a year at a cost of £55,000 per annum. This will be split between County and City.

Avoiding 'handover' as much as possible so that a vulnerable individual has continuity of support

Ensuring that both City and County providers are working to the same shift patterns so that a PM duty request can be actioned and that individuals are able to remain with the case until 8pm, rather than a risk of deferral to the next available day

Current activity levels have been used to estimate the split of the £55k between Derby City and Derbyshire County contracts which will be 60% to County and 40% to City. That equates to an uplift of £33k to the County contract and £22k to the City contract.

The PCC's contributions to the contracts will now be as follows:

Derby City contract £175k + £22k = £197k

Derbyshire County contract £89k + £33k = £122k

SUMMARY

The Commissioner will provide a single consistent specification for a Derbyshire wide IDVA service, to protect a consistent standard of service for victims, against a single

system linked with the criminal justice system. The additional cost is £55,000 per annum and is effectively one whole-time-equivalent additional post across the entire county.
