PURPOSE OF THE REPORT

To approve the decision to share the awarded grant of £18,700 to St. Peter's Quarter Derby Ltd with Derby City Pub Watch to further improve the efficiency of the digitalised radio system in Derby City. The split is £11,000 to St. Peter's Quarter Derby Ltd and £8,000 to Derby City Pub Watch. The existing Pubwatch and Store Watch scheme are two stand-alone systems. Both use Analogue radios, there is declining usage, a lack of monitoring and information sharing and regular hacking into the system.

1. OVERVIEW

- 1.1 St. Peter's Quarter Derby Ltd applied for a Commissioner's Community Action grant for funding to encourage and support the creation of a Radio Watch scheme amongst businesses in the Business Improvement District (BID) areas of Derby City including those registered with Store Watch scheme.
- 1.2 A new digital aerial is required along with the replacement of the existing Analogue radios with Digital equipment.
- 1.3 There will be an ongoing programme of training, encouragement, monitoring and support to ensure a take-up amongst businesses, which will be carried out by resource allocated by the Police Safer Neighbourhood team (0.4 officer FTE) and the BIDs (0.4 Ranger FTE).
- 1.4 The existing Pubwatch and Store Watch scheme in Derby are two stand-alone systems. Both currently use Analogue radios, there is declining usage, a lack of monitoring and information sharing and regular hacking into the system.
