## **INFORMATION AND ANALYSIS**

Derbyshire Constabulary's Information Services department established a WiFi capability throughout the new joint headquarters building following completion to increase internet accessibility for officers, staff and suppliers.

Due to the ever expanding demands being placed on IS systems, and the rollout of the mobile office project, it has become imperative that access to the internet is expanded to include other key locations around the force estate.

A further competition was conducted under the Crown Commercial Service Framework RM 1045, lot 2. 11 suppliers expressed an interest in this tender. 2 suppliers' submitted bids; Specialist Computer Centres PLC Virgin Media Business.

Most Economical Advantageous Tender Criteria (MEAT): Weighting 90% Price and 10% Quality (delivery).
