Executive Summary:

A budget was allocated for the purchase and was confirmed by Finance colleagues of £350,000.

Replacement handset bundles (handset, battery, antenna, charger, adapter, headsets, microphones, carrying case and extended warranty) are available via the framework at £539.00 each.

The Force requirement is 600 Bundles along with some additional desktop multi chargers, power leads and cables.

The supplier has further offered for orders prior to the end of January a reduction of £43 per bundle.

This offer equates to a saving of £25,800.

Total spend for the initial order is £308,169.00.

1. OVERVIEW

1.1 To recommend approval for the award of a call off contract, for the supply of Airwave Terminals and Associated Peripherals. To be provided by Sepura PLC for the initial term of 3 years with options to extend for a further 3 x 12 months periods.

1.2 The initial call off value is £308,169.00

2.

2.1 Derbyshire Officers are currently provided with Sepura SRH3900 Airwave Terminals. These terminals are now circa 8 years old have been out of warranty since April 2017. Repairs are expensive, approx. £200 per unit, and as this model is no longer available spare parts are becoming increasingly difficult for the supplier to obtain. For some time now old units which have become end of life have been used for replacement parts and the supplier has been taking units from other forces that have already upgraded, to further prolong the life of this terminal.

2.2 A number of delays to the commencement of the National Emergency Services Network (ESN) has meant that the Force has delayed the purchase of new and replacement handsets. This refresh program is now becoming more critical as the holding of replacement, and new issue, terminals is decreasing.

2.3 The proposed replacement terminal will be compatible with ESN.

3.

3.1 The Police ICT Company, on behalf of all UK Police Forces have established a national framework for the provision of Airwave Terminals and Associated peripherals.

3.2 The framework allows for either a further competition between, or the direct award of a contract with either of the two leading suppliers of these terminals to UK Police Forces Motorola and Sepura.

3.3 During mid 2018 colleagues from Ops Support and IS conducted trials using the latest technology offerings from both suppliers.

3.4 One particular supplier stood out as the preferred technology option, and when prices were compared along with the cost of change considerations which we would incur taking up the Motorola option, it was decided the most economically advantageous option was that offered by Sepura, our incumbent provider

4.1 A budget has been allocated for this purchase and has been confirmed by Finance colleagues of £350,000.
