#### Executive Summary:

Empowering-Communities (EC) have developed the ECINS system over a number of years with the assistance of Derbyshire Constabulary and the Police and Crime Commissioner. As a result, and being an early user favourable pricing is granted to Derbyshire.

Due to the level of development work over a number of years, added to the lack of an alternative provider in the marketplace that could provide the service at the same or similar level, the requirement was to contract with EC via a compliant route.

The Crown Commercial Services (CCS) G-Cloud Framework was identified as a compliant route to market, EC are a provider on this Framework. Having followed the guidance provided within the Framework regarding the shortlisting procedure, EC were the only company identified as being able to provide the requirements. Under these circumstances direct award is allowable under the Framework terms and conditions.

EC were requested to provide a quotation for the provision of the services required by Derbyshire.
