**DERBYSHIRE YOUTH OFFENDING SERVICE (DYOS): SPEECH AND
LANGUAGE THERAPIST (SALT) POST**

Executive Summary:

1. After reviewing national research, Derbyshire Youth Offending Service (DYOS) has recognised that at least 60 % of young people involved in the Youth Justice System have speech, language and communication needs (SLCN).
2. Currently DYOS staff are not sufficiently skilled to effectively support this group of young people. The proposed project would involve DYOS working in partnership with Derbyshire CCG to address this need.
3. This would be achieved by recruiting a Speech and Language Therapist to:

Train case managers within DYOS to work more effectively with young people with SLCN and to offer consultation to case managers on SLCN.

Develop/introduce a SLCN screening tool for case managers to use with all young people in the YOS.

Ensure that DYOS staff are aware of how to access appropriate support from health services pathways for young people with SLCN.
4. To add this additional £18,770 to the existing pot of £113,480 currently provided to the Derbyshire Youth Offending Service by the PCC through the Community Safety Grant.

The provision of a professional Speech and Language Therapist will have a positive impact on the outcomes of young offenders. This to be monitored through agreed KPIs under an additional Appendix to the existing Community Safety Grant agreement.

Decision:

Derbyshire Police and Crime Commissioner to match fund the provision of SALT post to the sum of £18,770 (match funding agreed by DYOS) and this contribution to be provided through the Commissioner's Community Safety Grant.

OVERVIEW

1. After reviewing national research, Derbyshire Youth Offending Service (DYOS) has recognised that at least 60 % of young people involved in the Youth Justice System have speech, language and communication needs (SLCN). Currently DYOS staff are not sufficiently skilled to effectively support this group of young people. The proposed project would involve DYOS working in partnership with Derbyshire CCG to address this need. This would be achieved by recruiting a Speech and Language Therapist to:

Train case managers within DYOS to work more effectively with young people with SLCN and to offer consultation to case managers on SLCN.

Develop/introduce a SLCN screening tool for case managers to use with all young people in the YOS.

Ensure that DYOS staff are aware of how to access appropriate support from health services pathways for young people with SLCN.

2. Proposed outcomes include:
 - The SALT will deliver training to case managers within DYOS. This will enable them to screen all young people's SLCN and to better work with those identified as having particular needs. The SALT will act as a consultant for DYOS staff offering specialist advice when required. Training could also be provided to Court and Police staff.
 - Re offending rates for young people in Derbyshire will show similar reductions (25%) to that evidenced in Milton Keynes. This has clear benefits for young people and the communities that they live in.

SUMMARY
