The Framework commenced on 01/12/18 and we can join the Framework at any time within that period and benefit from the full 4 year contract term from our date of joining.

OVERVIEW

To ensure compliance we need to join a new Framework Agreement once our current contract ends on 19 July 2019.

The Metropolitan Police have negotiated a new Framework Agreement with Aero Healthcare who are our incumbent supplier.

A desk top evaluation was carried out of the pricing/product selection offered by Banner Group who are our current supplier for stationery and who can also offer first aid supplies but the products on offer were more limited in comparison to Aero Healthcare and the pricing was comparable.
