**THE PROVISION OF PROFESSIONAL SERVICES TO ASSIST AND ADVISE  
REQUIREMENTS TO DELIVER THE NATIONAL ENABLERS PROGRAMME  
(NEP)**

**Executive Summary**

In June 2018 Derbyshire Constabulary signed up to the National Enabling Programme (NEP) provided via the Microsoft Office 365 (O365). The implementation of O365 is complex and Microsoft recommends the use of a Microsoft delivery partner to assist with the transition to O365 to achieve the benefits this system can bring to the organisation.

The Force require assistance to successfully deliver the NEP programme. Some of the key areas where support is required is detailed below;

- SharePoint
- Conditional Access
- Exchange Online and;
- PowerApps

A compliant route to market to procure the services has been identified via the CCS GCloud 12 framework which allows a direct award to the supplier, Minttulip. The initial value of the contract is £25,000.00, but there is scope throughout the term of the agreement to add services in line with the agreed day rates which are detailed within the agreement. The total value of the contract has been capped at £50,000.00. The contract is expected to go live on 1 February 2021, and will be in place for the period of 1 year. This is to allow for the services of MintTulip to be used again, if required, after the initial scope of work is completed.

**Decision**

To award contract for the provision of professional services to assist and advise requirements to deliver the National Enablers Programme (NEP) to Minttulip. The initial value of the contract is £25,000.00, but there is scope throughout the term of the agreement to add services in line with the agreed day rates which are detailed within the agreement. The total value of the contract has been capped at £50,000.00. The contract is expected to go live on 1 February 2021, and will be in place for the period of 1 year.
