**FUNDING DECISIONS FOR ROUND TWO OF THE NEIGHBOURHOOD
WATCH INNOVATION FUND.**

Executive Summary

Neighbourhood Watch (NHW) is key named partner in the Derbyshire Police & Crime Plan. To help strengthen this relationship, the PCC established the Neighbourhood Watch Innovation Fund (NIF) in 2019-20 which saw £2,500 allocated to local watch schemes situated across the county to support community safety initiatives. Due to the success and the desire from NHW for this to continue, the PCC has committed to re-launching this scheme again to run across 2020-21.

Due to demand from local watches, a decision has been made by the PCC to increase the total funding pot from £2,500 to £5,000. There will be two funding rounds for local watches to apply for funding up to a maximum of £300 per project.

Round Two

The PCC has agreed to fund eleven separate proposals received from Neighbourhood Watch Association Trust (DNWAT) from round two of the 20-21 Neighbourhood Watch Innovation Fund (NIF). In total, the combined value of all projects is £3,058.98. Details concerning the amount awarded, the local Neighbourhood Watch recipient, and brief details on what the funding will be used for are listed:
