THE PROVISION OF A NETWORK STORAGE SOLUTION

Executive Summary

The Nimble CS500 arrays are now end of life and the support and maintenance contract which is in place will expire on 10th December 2021, therefore a replacement storage system is required before the support and maintenance contract ends.

A tender was conducted under Lot 1 (Hardware, Software and Associated Services) of the Crown Commercial Service (CCS) RM6068 Technology Products and Associated Services Framework. The 22 suppliers named under Lot 1 of the framework were sent the tender documents. 14 suppliers expressed an interest in the tender, and 5 suppliers submitted a response. The tender was evaluated on the Most Economically Advantageous Tender (M.E.A.T) which was split between 70% quality and 30% price.

boxxe Limited were awarded 97.58, which was made up of 70.00 for their quality submission and 27.58 for their price submission.

The submission from boxxe Limited was within the original budget for this tender.

The total value of the contract is £374,674.84 which covers the initial contract period of 29 March 2021 to 5 years from go live (currently estimated to be 1 July 2021) with the option to extend for a further 2 x 12 months.
