Title: KCOM Contracts for Point to point circuits & voice calls and lines

Executive Summary: To be completed by PCC Specialist lead

The current KCOM contracts are due to expire therefore a single tender approval (STA) is requested to award a further short term contract with KCOM in order to allow time for the move over to an alternate supplier.

There are currently 2 contracts with KCOM that expire on the 31st December 2014 for Voice Calls & Lines Rentals and Point to Point Circuits. These contracts are under extension following a decision in June 2014.

New service design for voice has been delayed due to the complexity of the re-design, supplier lead times and availability of services. In addition, new information from neighbouring forces has brought to light service and technical issues from the supplier. The technical issues relate primarily to the voice element, therefore a 12 month extension to the KCOM contract would be required as an alternate solution/supplier may be required.

In respect of data services there are further contractor (novation) design and supplier issues which require a 9 month contract extension to allow for migration to the new supplier.

A condition of the approval is for a detailed implementation timetable is to be provided to the Commissioner to evidence that there is a controlled project in place.

Decision

Resolved that a 9 month contract be awarded to KCOM for point to point services and a 12 month contract for voice services with effect from 1 January 2015 and that a detailed implementation timetable be presented to the Commissioner.
