FOI Request: FOI 11/2018

I write in connection with your request for information received by the Police and Crime Commissioner for Derbyshire on 5 April 2018. A note of your request and our response is detailed below:

Please provide the register of premises or land owned by, or occupied for the purposes of, the office of Police and Crime Commissioner, and the functions of their force, for the financial year 2017/18.

Entries listed should be broken down by local policing directorate (or borough), and indicate whether it is:

- **Police building**
- **Other building/land**
- **Neighbourhood office**
- **Other**

I have today decided not to disclose all of the located information to you as I am claiming an exemption under S31(a)(b) - Law Enforcement in respect of all/some building locations/uses; the rationale for which is shown below.

On that basis please accept this letter as formal refusal of your request.

That said please see the attached spreadsheet for details of the buildings I am prepared to release at this time.

Refusal of Request – Section 17

Section 17(1) provides that -

“A public authority which, in relation to any request for information, is to any extent relying on a claim that any provision of Part II relating to the duty to confirm or deny is relevant to the request or on a claim that information is exempt information must, within the time for complying with section 1(1), give the applicant a notice which –

(a) States that fact,

(b) Specifies the exemption in question, and

(c) States (if that would not otherwise be apparent) why the exemption applies.”

Section 31 (a)(b) - Law Enforcement

Information is exempt from disclosure under section 31(1)(a) and (b) if its disclosure would be likely to prejudice the prevention or detection of crime or the apprehension/prosecution of offenders.
