1. OVERVIEW

These switches are required to support the Digital Information Ingestion programme (egress) implementation and improve resilience of the network due to the increased digital content volumes. The switches will also compliment existing Information Services infrastructure utilising technologies already familiar to IS technical colleagues.

A further competition was conducted under lot 1 of the Healthtrust Europe ICT Solutions Framework. 6 suppliers submitted expressions of interest. 3 suppliers submitted a responses; Specialist Computer Centres, Softcat PLC and XMA Ltd.
