**AMBIENT MEAL, IN-CUP DRINKS & RELATED ITEMS**

**Executive Summary:**

The provision of ambient meals for prisoners is on a National Framework Agreement through Kent Police. The contract ended on 30/06/19 and the new agreement commenced on 1st July 2019 with Bidfood remaining as the single supplier under the agreement. To remain compliant it is our intention to sign a call-off contract to allow Derbyshire to utilise the Framework and the new contract pricing.

Kent Police carried out a competitive tender process as a result of which a new Framework Agreement has been agreed with Bidfood for the supply nationally to all Police Forces of meals, in cup drinks and related items for detainees. Bidfood have been the sole supplier under a Framework Agreement for the last 4 years.
