Provision of Consultancy Services for Microsoft 365 Implementation

Derbyshire Constabulary require a partner to help design and support the planned Microsoft 365 implementation with particular emphasis on the design of the Security and Compliance Center.

The current Derbyshire MS 365 programme has 3 strands.

- Strand 1: PowerApps
- Strand 2: Security and Compliance Center
- Strand 3: Use Cases

The force need to understand the best way forward in the configuration of the Security and Compliance Center, to implement an MVP (minimum viable product) for the Security and Compliance Center. The aim being that the configuration provides a firm basis for long term requirements.

A proposal was received from Leadership Through Data (LTD) who are partnered with Metataxis. Metataxis are an independent consultant who specialise in information management, information architecture and Microsoft 365 and LTD are an experienced training provider.

A compliant route to market was identified under the G-Cloud 12 framework which allows for a direct award to Leadership Through Data. A call-off contract has been put in place for the period of 12 months, commencing on Monday 17 January 2022 for the initial contract value of £8,500.00. Please note: there is scope throughout the term of the agreement to add services in line with the agreed day rate. The total contract value will be capped at £25,000.00.
