1. OVERVIEW

- 2.1 The Assets Team currently use an outdated Assets Management System, however this system is no longer in support and maintenance and has been assessed as inefficient and has not been used by the Assets Team for some time. As a result, the Force is looking to source a new Asset Management System that supports a leaner and more effective way of working and will meet the documents business requirements and provide seamless working between the core partners such as the property maintenance/small works contractor.
- 2.2 This competition was an EU Open Procedure. 65 suppliers expressed an interest in this tender. 6 suppliers submitted a bid.
- 2.3 The submissions were evaluated against the Most Economical Advantageous Tender Criteria (MEAT): Weighting 40% Price and 60% Quality.
- 2.4 Based on the detailed evaluation, although Concerto Support Services Limited didn't receive the full 60 points for their quality score, they did receive 51.04. The evaluation panel confirmed that they demonstrated that they could meet the requirements which were outlined within the specification and provided a comprehensive response to the method statements.
- 2.5 Based on the evaluation of the pricing schedules, Concerto Support Services Limited received the full 40 points, as they were the most economical submission.
