#### PURPOSE OF THE REPORT

- To recommend to the Police and Crime Commissioner for Derbyshire (the Licensor) to enter into a limited use copyright licence with Doclisboa, the organiser of a film festival (the Licensee).
- 2) Doclisboa the Licensee is holding an international film festival between 18 and 28 October 2018 and would like to broadcast the Licensor's short film Evidence (1935), the earliest known police surveillance film to be used as evidence in a court case. The footage captures some illicit activities – and Circus animals in Chesterfield marketplace.
- 3) The Licensor has agreed to enter into a non-exclusive, non-transferable and non-sublicensable licence to use the Licensor's film Evidence at the Doclisboa Film Festival between 18 and 28 October 2018.

#### **OVERVIEW**

Derbyshire Constabulary have reviewed the existing processes relating to the ingestion of data from untrusted sources such as CCTV footage and dash cam footage via USB sticks, discs and SD cards. Currently the CCTV Process Unit is heavily relied upon to produce a viewable working copy which can be used on networked machines. This causes lengthy delays in most cases as internal mailing and travel between stations to collect exhibits is required. In addition to this there is a considerable number of police officer hours wasted attempting to collect footage from the source location.

This solution will enable the public and internal staff to easily upload digital content securely for access by the relevant users. The data will be made safe by virus checking in order for staff to extract it and save it to the force network.

By implementing this digital upload and viewing facility it will enable Derbyshire Constabulary to provide an enhanced service to the public, which should considerably reduce the amount of time wasted before digital evidence can be analysed.

This further competition was conducted under lot 2 (software) of the Crown Commercial Services (CCS) RM3733 Technology Products 2 Framework. 22 suppliers were invited to submit a response. 13 suppliers submitted expressions of interest. 3 suppliers submitted a bid.

The submissions were evaluated against the Most Economical Advantageous Tender Criteria (MEAT): Weighting 35% Price and 65% Quality.

Based on the detailed evaluation Softcat PLC received the full 65.00 points for their quality response. The two highest scoring bidders (Softcat PLC and Centerprise International Limited) were invited to present their solution to the evaluation panel. The 5% was awarded to the one bidder that demonstrated their solution best meets the requirements and which provided the most suitable user experience. Centerprise International Limited received full marks for their response to the method statements, but the additional 5% was awarded to Softcat PLC. The evaluation panel were satisfied that the response from Softcat PLC could meet the requirements which were outlined within the specification.

Softcat PLC received the full 35.00 points, as they were the most cost-effective submission. The submission from Softcat PLC was within the original budget for this project.
