OVERVIEW

Concerns have been raised as to the validity of previous electrical testing carried out, and whether the remedial works noted have been completed. This is an area of statutory compliance and needs addressing as a matter of urgency. The top 10 buildings have been identified by the Assets Team, and as such, these will be inspected and repaired as a matter of urgency.
