#### **OVERVIEW**

The existing risk management and assurance system has been in place for 5 years and is now end-of-life. Leicestershire Police locally host this system on behalf of Derbyshire Constabulary, so the procurement was done for both forces.

A new solution is required for users to record all departmental and strategic risks with relevant controls and actions in addition for the ability to assign risk owners and risk levels based on a shared risk matrix.

The evaluation team consisted of Kirsty Holding (Procurement Assistant), Ray Poxon (Head of Procurement), Ellen Stone (IS Business Analyst), Mark Euerby (Head of Corporate Risk), Andrew Dale (Chief Finance Officer, OPCC), Dean Langton (Technical Development Manager), Daniel Finch (Information Security Support Officer) for Derbyshire Constabulary and Laura Saunders (Risk and Business Continuity Advisor) for Leicestershire Police.

This further competition was conducted under the Open Procedure. 46 suppliers submitted expressions of interest. 5 suppliers submitted a bid.

Based on the detailed evaluation CAM Management Solutions received the highest points for their quality response. The method statements and business requirements were scored separately hence why none of the bidders received the full 60 points. The three highest scoring bidders were invited to present their solution to the evaluation panel. The evaluation panel were satisfied that the response from Keto Software Limited could meet the requirements which were outlined within the specification.

Keto Software Limited received the full 40.00 points, as they were the most cost-effective submission. The submission from Keto Software Limited was within the original budget for this tender.
