**POLICE AND CRIME COMMISSIONER COMMUNITY ACTION

**Executive Summary:**

1. Community Action Grants will provide funding to promote partnership working with the Commissioner in Derbyshire and help to deliver the objectives of his Police & Crime Plan.
2. There is one round of applications per year (total allocation £200,000) for a Large Grant (between £2,501 and £25,000) and up to three opportunities per year (total allocation £75,000) to apply for a small grant (up to £2,500).
3. The Commissioner has committed this budget for each year of his term as Police and Crime Commissioner up to May 2020 when Police and Crime Commissioner elections will take place once again.
4. This report supports the decisions to award a further small grant to Junction Arts under the Commissioner's Community Action Grant.
5. The project awarded a grant will receive funding for up to a 3 month period.
6. The project will be match funded by Bolsover District Council by £1250.
7. The project is needed to provide low-cost innovative creative community cohesion activities which can provide positive role models for young people in particular, as well as discouraging anti-social behaviour by working together to develop a sense of wellbeing and pride in the local area.

## **1. OVERVIEW**

- 1.1 In 2016-17, Hardyal Dhindsa, the Police and Crime Commissioner for Derbyshire, has committed to share £275,000 among community safety organisations that will help him to deliver his Police and Crime Plan priorities.
- 1.2 These priorities include keeping vulnerable people safe from harm, supporting victims, maintaining strong and effective partnership working, tackling drugs and alcohol, supporting those with mental health issues and working with young people to break the cycle of offending and repeat victimisation.
- 1.3 He has invited community groups, non-profit making organisations and third sector organisations to work with him to deliver his priorities at a local level.
- 1.4 Community Action Grants will provide funding to promote partnership working with the Commissioner in Derbyshire and help to deliver the objectives of his Police & Crime Plan.

- 1.10 The project is needed to provide low-cost innovative creative community cohesion activities which can provide positive role models for young people in particular, as well as discouraging anti-social behaviour by working together to develop a sense of wellbeing and pride in the local area.
- 1.11 Bolsover is the most deprived of Derbyshire's districts, ranking 61st out of 326 local authorities. However, it is noted as being one of ten local authority districts across England that has experienced the greatest relative

improvement in deprivation levels between 2010 and 2015. This project, along with other initiatives, will have contributed to that improvement and should therefore continue to maintain/further develop future improvements.

1.12 Bolsover Town Centre continues to experience problems with large groups of young people congregating and ‘roaming’ through the town and parks causing ASB. This project provides intergenerational activities for all age groups that facilitates collaborative learning between the generations. This can result in reduced fear in older adults of young people’s behaviour and improve attitudes of the young towards the elderly. The project promotes pride in the identity of the local area together with increased community cohesion and mutual respect. This should lead to greater tolerance of young people by older adults and a reduction in ASB caused by young people in the area.
