This further competition was conducted under the EU Open Procedure. 58 suppliers submitted expressions of interest. 4 suppliers submitted a bid.

OVERVIEW

Derbyshire Constabulary have assessed the current capabilities in force with regards to open source research. It has been identified that there is a need to increase this capability and capacity across the organisation in response to the increasing requirement to secure digital evidence. There is also a need to ensure that a robust audit facility is available for those conducting research, to ensure compliance with legislation. It is also vital that the proposed solution will support covert investigations and that the integrity of tactics used by investigators is maintained.

This further competition was conducted under the EU Open Procedure. 58 suppliers submitted expressions of interest. 4 suppliers submitted a bid.

The submissions were evaluated against the Most Economical Advantageous Tender Criteria (MEAT): Weighting 40% Price and 60% Quality.

Based on the detailed evaluation Internet Investigation Solutions Limited received the full 60.00 points for their quality response. The evaluation panel were satisfied that the response from Internet Investigation Solutions Limited could meet the requirements which were outlined within the specification.

Internet Investigation Solutions Limited received the full 40.00 points, as they were the most cost-effective submission. The submission from Internet Investigation Solutions Limited was within the original budget for this project.
