Overview

Currently we have 3 wooden type dog kennels that are in beyond economical repair. The kennels need replacing and to give longevity of life, it has been decided to construct on a concrete bed using block work, the kennels will also have heating. The new build should result in minimal maintenance for the fabric of the building next 20 years.

The evaluation team consisted of Joan Watson & Ian Tomblin.

This tender was run as a Further Competition, and advertised on EU-Supply and Source Derbyshire, using the Most Economical Advantageous Tender Criteria (MEAT): Weighting 40% Price and 60% Quality (delivery).

15 Companies expressed an interest, 5 Companies submitted bids, 2 bids were non-compliant and so 3 bids were evaluated.

Based on the detailed evaluation, Tour Construction Ltd scored highest on the combined quality and cost total figure. They demonstrated that they could meet the requirements which were outlined within the specification and provided a comprehensive response to the method statements.
