# 1. OVERVIEW OF SERVICE CHANGE

1.1 <u>Victim Triage Unit</u> – In September 2018 a business case was provided for the move from current business operations managed by both the Force and OPCC to a single Victim & Witness Triage Unit hosted by the Force but funded through both the Force and PCC budgets. The overall benefits of the change will be:

- Improve the victim satisfaction rates for the Force;
- Improve the victim experience of cope and recovery from the crime and associated criminal justice experience through improved victim conversations and management of referrals to appropriate victim services;
- Monitor, improve and evidence VCOP compliance of the Force;
- Increase the likelihood of positive outcomes and convictions at court;
- Improve and evidence compliance with GDPR for both the Force and OPCC.

For Stage One funding of the Unit will be containable within Force (c28K) and OPCC (c58K) existing resources, including estate. This stage will be completed by January 2019. (Full report available)

- 1.2 <u>Re-procurement of CORE High Risk Domestic Abuse Service</u> the contract for the CORE IDVA service terminates in March 2019. This is significant part of the core victim services offer support to high risk domestic abuse victims. An open procurement process was undertaken and the contract awarded in December 2018 to ARCH which is a Staffordshire-based housing group. The contract is for £197,000 and is aligned to the County specification creating a uniform approach across the City and County. The new specification extends the hours of operation and is intended to provide a higher quality of service to victims.
- 1.3 <u>Re-procurement of CORE Sexual Violence Service</u> the contract for the standard level service to victims of sexual violence and abuse ends in March 2019. This service is being re-procured at the present time with a view to mobilisation from April 2019 to compliment the NHS offer through the SARC. The service specification has been widened and enhanced to incorporate family

members and secondary survivors and offer a broader service to sexual violence victims.

<u>1.4 Extension to CORE Generic Service</u> - the service has been extended for one year to support the CORE offer to all victims of crime and work in collaboration with the new Triage unit to enhance the support offered to all victims. Early analysis suggests an increase in referrals to the service and a conversion rate which has facilitated greater access to this service at the time of reporting. The current contract value is £345,000.

# 1.5 Extension to CORE medium risk DA service in the City

The service has been extended for a further year within the scope of the existing contract to create a stable framework of services for Domestic abuse victims and allow for partnership work to be encouraged with the new IDVA service in the City. The provider is working systematically to improve performance and offer an appropriate range of services for standard and medium risk victims and to provide information to address the new specification for 2010.
