## **OVERVIEW**

On the 1st of October 2014, the Police and Crime Commissioner (PCC) for Derbyshire took over responsibility from the Ministry of Justice for commissioning victims services. Derbyshire was one of seven PCC areas nationally which were early adopters of the new commissioning system, ahead of the deadline of the 1st April 2015. *For the purpose of this specification 'county' and 'Derbyshire' means the geographical county and therefore includes the city.*

To achieve these outcomes, all commissioned providers will need to develop and support the work across Derbyshire as a partner to ensure a whole systems approach for victims.

The overall vision and ambition is to reduce the number of victims and crimes over time, deliver positive outcomes for victims and communities, improve and ensure equal access and increase the confidence and number of people coming forward for support and/or to report the crime to the police.

To do this the PCC works in partnership with Derby City and Derbyshire County Councils, Derbyshire Constabulary, the Criminal Justice Service and voluntary and public sector statutory providers of services, towards the shared ambition of a consistent and seamless victim service across city and county, whatever the assessed risk or need. This work includes wide consultation with victims' services and key stakeholders in Derbyshire.

In April 2016, a contract was awarded to provide a standard level of support for victims of sexual abuse and violence. This was in addition to the Adult SARC service contracted separately which included the ISVA service, for those requiring therapeutic, forensic and medical services.

In March 2018, the contract for the standard service was extended for a year up until March 2019. The evolution of the service had demonstrated that there were areas of service "gap" which could be filled with the Core service to compliment the SARC and PSARC. The CORE service requires the flexibility to respond to changing patterns of the victim profile and emerging needs such as wider family needs, historical abuse and secondary survivors. The inter-operability between all services needs to be effective and streamlined, in this specific case between the CORE SA&V service, the CHISVA, the Adult and Paediatric SARCs.

The evaluation team consisted of Kevin Gillott (Deputy Police and Crime Commissioner), Dawn Robinson (Head of Commissioning, OPCC), Chief Inspector Claire Hammond (Operations Manager), Sarah Greensmith (Commissioning and Grants Officer), Kirsty Holding (Procurement Assistant) and Rob Atkinson (Procurement Officer) for Derbyshire Constabulary.

This competition was conducted via an EU Open Procedure. 12 suppliers submitted expressions of interest. 1 supplier submitted a bid; SV2 – Supporting Victims of Sexual Violence Limited.

Based on the detailed evaluation SV2 Supporting Victims of Sexual Violence Limited received the full 60.00 points for their quality response as they were the only submission. The evaluation panel confirmed that they demonstrated that they could meet the requirements which were outlined within the specification.

Based on the evaluation of the pricing schedules, SV2 Supporting Victims of Sexual Violence Limited received the full 40 points, as they were the only tender submission. The submission from SV2 Supporting Victims of Sexual Violence Limited was within the original budget set for this procurement.
