OVERVIEW

The current contract is on a Framework Agreement arranged by North Yorkshire Police which was for 3 years plus 1 year extension, with Alere Toxicology PLC.

North Yorkshire Police have advised they will not be leading a new framework and have advised us of the availability of the drug testing services, under the NHS Shared Business Services Framework.

Following a desk top evaluation between the two available suppliers under the Drug Testing framework, Alere Toxicology came out as the best in terms of value for money and also as the incumbent supplier, continuity of the service provision. There have been no issues with this supplier in the last 4 years that we have used their services.

It is therefore our intention to direct award this contract to Alere Toxicology under the NHS Shared Business Services Framework Agreement.
