#### Overview

Currently Alfreton Police Station requires extensive alteration and refurbishment to transform it into a SARC unit. The evaluation team consisted of Joan Watson, Rob Atkinson and Steve Wild.

This tender was run as a Further Competition, and advertised on EU-Supply and Source Derbyshire, using the Most Economical Advantageous Tender Criteria (MEAT): Weighting 50% Price and 50% Quality (delivery).

34 Companies expressed an interest, 10 Companies submitted bids, 2 bids were non-compliant and so 8 bids were evaluated.

Based on the detailed evaluation, Key Property Solutions Limited scored highest on the combined quality and cost total figure. They demonstrated that they could meet the requirements which were outlined within the specification and provided a comprehensive response to the method statements.
