This framework offers a variety of courses and the offender pays and books direct on to the courses available within the county. offenders have the option to book with any provider within any area regardless of where the offence occurred, this one is managed by Drive Tech uk ltd.

The current framework agreement with the same supplier Drive Tech uk ltd undertaken by Thames Valley police expires on 12th January 2020.

This is against an existing Framework Agreement for the provision of National Driver Offender Retraining Schemes set out within contract reference C-4-0181-18 undertaken by the police and crime commissioner for Bedfordshire dated 24th June 2019.

This will give us an OJEU compliant route to market.
