1. OVERVIEW

The current contract is due to expire therefore the Commissioners from The Office of the Police and Crime Commissioner (OPCC) for Derbyshire, Derby City Council and Derbyshire County Council were seeking to appoint a suitably experienced provider or consortium to deliver a service to support children and young people vulnerable to Sexual (CSE) and where appropriate wider forms of exploitation.

The Service will directly support children and young people, who are at significant risk of being sexually and/or exploited (medium and high risk). This will result in a person-centred plan that improves their individual outcomes and builds future resilience against risk of exploitation. The Service will operate in the City and County for referrals and will encourage self-referral from individuals and families.

This competition was conducted via an EU Open Procedure. 21 suppliers submitted expressions of interest. 4 suppliers submitted a bid.

Based on the detailed evaluation, Catch 22 received 95.00 points for their quality response as they provided a comprehensive and detailed response to the method statements. The bidders also had the opportunity to obtain 5.00 additional points at a supplier presentation.

Based on the evaluation of the pricing schedules, Catch 22 received the full 5 points as their submission was the cheapest.

The submission from Catch 22 was within the overall budget for this tender.
