Using the above mentioned criteria the bids were evaluated and the submission from Cable Dynamics Limited, who are the incumbent supplier was the successful bld. The pricing was evaluated on the basis of a set list of potential cable requirements and service charges which don't provide a firm fixed contract

24 companies expressed an interest, 4 bids were submitted of which 2 were non-compliant and therefore, 2 bids were evaluated.

The bids were evaluated by Joan Watson, Jennifer Cawkwell, Paul Grosse, Andrew, Hartshorne, Phil Munton and Jo Bingley.

SUMMARY

It is our recommendation to award the contract for a 2 year period with the option to extend for a further 2 x 12 months to Cable Dynamics Limited.
