OVERVIEW

We currently don't have any agreement or contract with coach hire companies for their services. We have a potential requirement for Derbyshire to provide officers to support other forces in the UK in respect of policing port areas following Brexit but additionally there are low key/low risk national events at which Derbyshire may be required to provide officers (e.g NATO Summits). In order to avoid police vans making multiple trips it is considered more cost effective and efficient to use local coach hire companies to take and collect officers.
