**PROVISION OF SIP TRUNKS**

**Executive Summary**

The Force is wholly reliant on effective, resilient telecommunications to effectively discharge its Public Safety Duty.

Our incumbent supplier (Virgin Media) provides SIP Trunks to Derby (SMW) and Ripley (CMaRC) locations in an active, active posture. Each trunk carries 60 Lines (120 in total). We are looking to increase capacity to 90 lines per location (180 in total).

The current agreement is due to expire on 21 February 2021; therefore, a new contract is required.

A mini-competition was conducted against the Crown Commercial Service (CCS) Network Services 2, Lot 3. The 33 suppliers who are named on this framework were sent the ITT document. 27 suppliers expressed an interest in the tender and 2 suppliers submitted a response. The tender was evaluated on the Most Economically Advantageous Tender (M.E.A.T) which was split between 70% quality and 30% price.

Gamma Telecom Limited were awarded the full 70.00 points for their quality submission, and the full 30 points for their price submission as they were cheapest submission.

The submission from Gamma Telecom Limited was within the original budget for this tender.

The initial value of the contract is £97,747.00 and will commence on 29 January 2021 to 28 January 2024 with the option to extend for a further 2 x 12 months.

**Decision**

To award contract to Gamma Telecom Limited. The initial value of the contract is £97,747.00 and will commence on 29 January 2021 to 28 January 2024 with the option to extend for a further 2 x 12 months.
