OVERVIEW

AA services within Derbyshire are currently provided by the Appropriate Adult Service (AAS). This is a joint contract arrangement between Derbyshire Constabulary, Derbyshire County Council and Derby City Council. The contract is held by the Office of the Police and Crime Commissioner for Derbyshire.

The AAS provides full 24-hour coverage on a call out basis. Due to the importance of the force ensuring an AA is provided for those who may need one, to ensure the protection of rights, the prevention of miscarriages of justice and compliance with PACE, the service is costly and is unlikely to reduce at any point in the future, current forecasts indicate that under the present system, costs may increase. Since the contract has begun, the use of AAs has increased dramatically meaning that original forecasted costs were incorrect.

As a result of this the OPCC, along with funding partners, are exploring different models of working to reduce costs while maintaining a quality service. This includes exploring in-situ models alongside call-out, volunteer models and hybrids of both. In order to provide the time for this work to be undertaken the current service has been extended up to March 2021.

SUMMARY

BACKGROUND

Appropriate Adults (AA) safeguard the rights, entitlements and welfare of children and vulnerable persons when they are detained or questioned as a suspect in an investigation under the Police and Criminal Evidence (PACE) Act 1984. The AA has a defined role under PACE, namely, to provide the support, advice and assistance necessary to ensure fair treatment, effective participation and guard against false confessions. AAs help the police to fulfil their responsibilities under PACE and are a critical safeguard against the abuse of police powers.

Under the Crime and Disorder Act 1998, it is a statutory responsibility for the Local Authority to provide an AA for any young person who may find themselves in need of one (a young person is defined as under the age of 18). However, AA provision to protect vulnerable adults is not as clear cut. According to PACE, 'if at any time an officer has any reason to suspect that a person of any age may be vulnerable, in the absence of clear evidence to dispel that suspicion, that person shall be treat as [vulnerable]'. This definition varies greatly from the definition that Local Authorities work to. Despite PACE clearly stating that a vulnerable adult must have the support of an AA, there is no statutory duty to fund this provision.
