Executive Summary

Specsavers Ltd have been the supplier of eyecare services to Derbyshire Police for many years and their service has found to be of a high standard. The current contract is on the DWP Framework Agreement and our call off contract ends on 30th April 2020. We therefore have a need to find a route to market to meet our ongoing requirements.

Frameworks from CCS and the NHS were considered and after discussion with the HR the NHS Shared Business Services Workforce and Wellbeing Framework Agreement was chosen as the preferred route due to the flexibility of the framework term. Three suppliers are available for the supply of eyecare services on the NHS Framework one of which is Specsavers the incumbent provider. The framework allowed for direct award and in view of past experience it was considered a direct award to Specsavers to be the best option.

Decision

To award the contract for 2 years to Specsavers Optical Superstores Limited with an option to extend for a further 1 x 24 months.

A desk top evaluation was carried out which determined that all three suppliers have a very similar offering in terms of service and price and therefore taking in to account
