PROVISION AND DELIVERY OF A DIGITIAL LEADERS PROGRAMME TO DERBYSHIRE COUNTY AND DERBY CITY.

Executive Summary

Commissioners from The Office of the Police and Crime Commissioner (OPCC) for Derbyshire and Derbyshire County Council were seeking to appoint a suitably experienced provider or consortium to deliver a professional and expert online safety training programme which is aimed at KS2 (Years 5 and 6). This will be delivered to all primary and junior schools in 5 Local Childrens Partnership areas in the County* including special schools and also in Derby City.

A pilot online safety project funded by the Police and Crime Commissioner for Derbyshire (PCC) was delivered between 1 April 2018 and 31 March 2019 to Years 5 and 6 in the Chesterfield locality.

A tender was conducted via the open procedure. 56 suppliers submitted expressions of interest. 1 supplier submitted a response – E-Safety Training Limited.

E-Safety Training Limited provided a comprehensive response to the method statements and were therefore awarded the full points available.

The response from E-Safety Training Limited was within the original budget for this tender.

The contract has been awarded to E-Safety Training and will cover the period from 13 July 2020 to 2 years from Go Live (currently estimated 7 September 2020), with the option to extend for a further 12 months for the initial contract value of £104,031.20.
