# THE PROVISION OF FINGERPRINT ENHANCEMENT LABORATORY (FEL) EQUIPMENT

## **Executive Summary**

The Fingerprint Enhancement Laboratory require the purchase of up to 3 Ninhydrin ovens to replace the existing ovens in use which are nearing the end of their life. A maintenance and repairs support package is also required for the period of the contract.

The existing ovens were recycled from the five forces at the time of collaboration to form EMSOU-FS, in order to maximise savings.

The contract will be for an initial 3 year term with the option to extend for 2 x 12 months. The initial contract period will be from 1st October 2020 to 30 September 2023.

A competitive tender process was conducted under the EU Open Procedure, six suppliers submitted expressions of interest of which two suppliers submitted a bid, Forenteq Limited and Fumecare Limited.

Based on the detailed evaluation ForenteQ Limited received the highest points for their quality response and the evaluation panel were satisfied that the response from ForenteQ Ltd could meet the requirements outlined within the specification. Pricing was evaluated on the basis of the pricing schedule submitted which detailed the cost for one oven, all accessories and filters, initial and ongoing training and three years service and maintenance. The successful bidder's price is  $\pounds$ 31,460.00.

The purchase of additional ovens during the contract period will be subject to budget availability.

#### Decision

To enter into contract with ForenteQ Limited for the purchase of one oven, all accessories and filters, initial and congoing training and three years' service and maintenance at a price of £31,460.00
