**THE PROVISION OF MARKED ARMED RESPONSE UNIT (ARU) VEHICLE
CONVERSION (VARIATION TO CONTRACT)**

Executive Summary

A need has been identified for the conversion of 6 x new Roads Policing Vehicles (RPU) before the end of the calendar year.

The option of a new call-off contract against the Sussex Police Vehicle Conversion Services framework agreement has been discounted as not being cost effective due to the imminent end date of the agreement in February 2021 which only permits call-offs to extend up to 12 months after the end date.

An existing contract exists with a vehicle conversion specialist, Woodhall Nicholsons T/A CM Specialist Vehicles which commenced on 1st September 2017 for a 4 year term via the Sussex Police Framework for the conversion for Marked and Unmarked Armed Response Unit Vehicles. The end date of this contract is 31st August 2021 which has an estimated overall value of £107,950 for the conversion of an estimated 10 Armed Response Unit Vehicles during the contract period.

The proposal is to vary the existing contract to include the RPU vehicles as permitted under Regulation 72 of the Public Contract Regulations 2015 provided the value is not in excess of 50% of the overall contract value. Quotations have been obtained from the supplier which total £39,603.50 thereby falling below this threshold.

Decision

To vary the existing contract with a vehicle conversion specialist, Woodhall Nicholsons T/A CM Specialist Vehicles to include the RPU vehicles.
