THE PROVISION OF DERBYSHIRE DRIVE

Executive Summary

The Drive Project is a new response to domestic abuse that aims to reduce the number of child and adult victims of domestic abuse by disrupting and changing perpetrator behaviour. It implements a whole-system approach through an intensive individual case management intervention alongside a co-ordinated multi-agency response to drive perpetrators to change their behaviour. The Drive Project focuses on increasing victim safety alongside the crucial protective work of victims' services. The service has been developed to knit together existing services, complementing and enhancing existing interventions.

The Drive Project focuses on priority high-risk or serial perpetrators, both male and female, aged 16 and over, as this group carries the greatest risk of serious harm and engage poorly in available services. By addressing perpetrators' behaviour Drive targets the root cause of domestic abuse and improves outcomes for victims and children.

The Drive Project was developed through a collaboration between three organisations, Respect, Safe Lives and Social Finance, who form the Drive Partnership. Drive was launched in 2016, initially piloted in Essex, South Wales and West Sussex, and highlighted in the government's VAWG strategy for its innovative approach. Subsequently Drive has expanded into Croydon, West Mercia and the West Midlands.

With the support of Local Authorities, PCCs and the National Lottery Community Fund (NLCF), Drive is now being implemented in up to three further areas, of which one area is Derbyshire. The service in Derbyshire will provide a multi-skilled

team of at least 4 full time equivalent (FTE) Case Managers and a Perpetrator Panel Co-ordinator, plus a full time Service Manager.

A tender was conducted under the OJEU open procedure. 18 suppliers expressed an interest in the tender, and 2 suppliers submitted a response. The tender was evaluated on the Most Economically Advantageous Tender (M.E.A.T) which was split between 95% quality and 5% price.

Honeycomb Charitable Services Limited were awarded 99.99 made up of 95.00 for their quality submission and 4.99 for their price submission.

The submission from Honeycomb Charitable Service Limited was within the original budget for this tender.

The total value of the contract is £1,077,042.00 which covers the initial contract period of 1 February 2021 to 31 March 2023, with the option to extend for a further 2 x 12 months.
