# THE PROVISION OF IT HARDWARE, SOFTWARE AND ASSOCIATED CONSUMABLES

# **Executive Summary**

The Force have an on-going requirement for IT Hardware, Software and Associated Consumables and therefore was keen to establish a partnership with a supplier in order to meet the Force's requirements.

The contract is set up as a framework agreement for use by Derbyshire Constabulary. Derbyshire Fire and Rescue Service are also be named on the framework should they wish to use it in the future.

A tender was conducted via the EU Open Procedure. 133 suppliers expressed an interest in the tender and 6 suppliers submitted a response. The tender was evaluation on the Most Economically Advantageous Tender (M.E.A.T) which was split between 60% quality and 40% price.

Insight Direct (UK) Limited were awarded 55.91 for their quality submission, and 34.66 for their price submission.

The value of the framework agreement is capped at £15million and will commence on 1 February 2021. The framework agreement will expire on 31 January 2024, with the option to extend for a further 3 years in annual increments.
