# THE PROVISION OF CONSULTANCY SERVICES FOR THE NEXT GENERATION NETWORK PROJECT – PHASE 2

# **Executive Summary**

IS required the services of a consultant in order to review the Force's current network and provide impartial advice regarding the next generation network and the Force's vision. An initial 10 days were provided (contract reference: DP0554) by Mason Advisory which completed the 'as is' work, but IS now require the services of a consultant to review the network strategy. In order to conclude the review which has already commenced, IS have requested Mason Advisory provide the consultancy services again.

A compliant route to market has been identified under the G Cloud 12 framework which allows for a direct award to Mason Advisory.

It is anticipated that the provider will deliver 10 - 15 days of consultancy. A quotation has been provided for the value of £18,000.00. In order to allow for additional consultancy services to be purchased if required, the contract will be in place for the period of 12 months, and will be capped at £30,000.00.

## Decision

To award contract to Mason Advisory for the provision of consultancy services for the next generation of network project – phase 2.

It is anticipated that the provider will deliver 10 - 15 days of consultancy. A quotation has been provided for the value of £18,000.00. In order to allow for additional consultancy services to be purchased if required, the contract will be in place for the period of 12 months, and will be capped at £30,000.00.
