The Provision of Support and Maintenance for Chronicle Framework, Firearms
Training and Weapons and Armoury Management Software Inc. Support and
Maintenance for Firearms Licence Software and Assets Cabinets Software

This request relates to the variation of an existing Call-Off contract with the supplier, JML Software Solutions Limited. The contract relates to the purchase of support and maintenance of the Firearms Assets Cabinets software "Chronicle" and the request is to add the purchase of additional asset cabinets and software support for the duration of the existing contract.

The Operational Support Department have recognised a need to introduce a centrally managed pool issue system for Tasers to replace the current arrangement of personal issue Tasers to their officers. In order to effect this change additional centrally located Taser storage cabinets plus related hardware and software support are needed.

The original contract was awarded for 4 years with the option to extend for 12 months. The contract period is:

1<sup>st</sup> September 2018 – 31<sup>st</sup> August 2022 (plus 1 x 12 month extension). The value of the contract was £57,279.28.

The cost of the new equipment including 15 months of product support (to align with the current contract end date) is £18,400 + vat. If the further 1 year extension is taken up in June 2022 the annual support costs will be £1,200.

In total the additional costs for the purchase will be £19,600 + vat.

As the value is less than 50% of the original contract value a variation to the agreement is permitted under Regulation 72 of the Public Contract Regulations 2015.

Funding availability has been confirmed by the Strategic Finance team.

## **Decision**

To agree to the variation of an existing Call-Off contract with the supplier, JML Software Solutions Limited. The contract relates to the purchase of support and maintenance of the Firearms Assets Cabinets software "Chronicle" and the request is to add the purchase of additional asset cabinets and software support for the duration of the existing contract.
