

### Voicemail IP Telephony Call off Contract

The current agreement for Voicemail and IP Telephony Support and Maintenance is due to expire on 31 March 2022. The Alcatel phone system provides critical and standard telephony voice services to the Force. A route to market was identified via the Derbyshire IT Hardware, Software and Consumables framework which is in place with Insight Direct (UK) Limited and offers a compliant route via direct award. The contract for the Provision of Voicemail and IP Telephony Support and Maintenance is therefore to be awarded to Insight Direct (UK) Limited (of which will be provided by Amillan Limited) for the total contract value of £198,039.93, which covers the period of 3 years from 1 April 2022 to 31 March 2025.
